Policy and Permission Guidelines on Use of the Orange County REALTORS®

Brand Name in Conjunction with the Affiliate Logo

Usage of the OC REALTORS[®] Affiliate logo is intended for an active, individual Affiliate member of the Orange County REALTORS[®]. Dues and fees must be paid in full for the current year. The logo is for Affiliate members' use only to show membership with the Association, and it is not as an endorsement for the individual or the company. The OC REALTORS[®] Affiliate logo may not be used in any manner that expresses or might imply OC REALTORS[®] affiliation, sponsorship, endorsement, certification, or approval of a specific Affiliate or any of their products or services. The Association's main logo may not be used without OC REALTORS[®] written permission.

By using the OC REALTORS[®] Affiliate Logo, you agree to comply with and be bound by the following terms of use:

- Use of logo is by permission only.
- Only active, individual Affiliate members of the Orange County REALTORS[®], in good standing, are allowed to use the logo. NOTE: When used, it must be used in a way that is clear that the membership belongs to the individual, and it is not for general company overall usage.

AFFILIATE CODE OF CONDUCT

Article 1
