I agree not to transmit the information to any participants, subscribers or clerical users not authorized to access the system by the rules. I agree not to use the MLS to create another product except as may be used by the participant who downloaded the data in compliance with the MLS rules.
- I agree I will not give or sell my password to any person or make it available to any person. I further understand that the California Penal Code and the United States Code prohibits unauthorized access to computer databases. I agree not to allow such unauthorized access through use of my equipment or pass codes.
- I understand that unlicensed assistants may be authorized to have limited access to the MLS for clerical support only. ### Mandatory Broker Compliance—Variable Dues Formula

The California Association of REALTORS® (C.A.R.), in accordance with the National Association of REALTORS® Bylaws, mandates that all associations comply with the "Variable Dues Formula" for Designated REALTOR® brokers. Using California Department of Real Estate (DRE) records, C.A.R. compares licensees under each broker against the licensees who are dues-paying REALTOR® members. There are options for compliance: (1) the licensee joins OC REALTORS<sup>®</sup>, C.A.R., and NAR and pays REALTOR<sup>®</sup> dues (and receives all REALTOR<sup>®</sup> benefits); (2) the broker is billed \$615 for that individual as a nonmember licensee (no REALTOR® benefits are realized with this option); (3) the broker terminates the nonmember licensee by removing the licensee from his/her DRE record; or (4) licensees working for a separate entity owned by the broker, which is exclusively engaged in referring clients to the broker, can be excluded from the dues calculation. Brokers must submit OC REALTORS® LFRO form, which identifies these referral agents; (5) affiliated MLO licensees in your firm may be excluded from your dues calculation provided them meet certain criteria. Brokers must submit OC REALTORS® MLO Certification Form which identifies these individuals. Failure to comply with the Variable Dues Formula may result in suspension of your REALTOR® membership, which will affect your membership benefits and those of the REALTORS® under your license. Please visit our website at www.ocrealtors.org to review the information about "Broker Compliance" and to obtain the LFRO and/or MLO Certification forms (if needed).

### NAR Code of Ethics and New REALTOR® Orientation

Applicants for REALTOR® membership and provisional REALTOR® members (where applicable) shall complete an orientation program on the Code of Ethics, meeting the minimum criteria established by NAR for new member ethics training. This requirement does not apply to applicants for REALTOR® membership or provisional members who have completed comparable orientation in another Association, provided that REALTOR® membership has been continuous, or that any break in membership is for one year or less.
