This form only updates your information with OC REALTORS®. You are responsible for notifying the DRE. When an agent transfers from one office to another (even within the same brokerage) all access to the listings are lost by the agent and broker unless the listings are transferred to the new office, or reassigned to a different user ID in the previous office. This affects all listings in the statuses of Active, Active Under Contract, Pending, Hold Do Not Show, and Withdrawn statuses.
